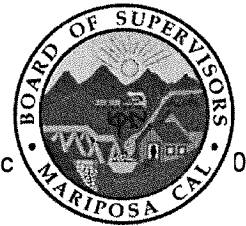

RE: California DHCS Agreement 14-90328 with Behavioral Health

RECOMMENDATION AND JUSTIFICATION:

Approve an Agreement 14-90328 with the State Department of Health Care Services authorizing Mariposa County Behavioral Health to provide community mental health services and setting forth conditions and requirements that the County must meet in providing those services, and authorize the Human Services Director to sign the Agreement and any subsequent amendments (Subject to County Counsel Review and Approval as to Form).

This contract renews a performance agreement with the State Department of Health Care Services (DHCS) which enables Mariposa County Behavioral Health to serve Medi-Cal Beneficiaries and claim Medi-Cal reimbursement. The term of this Agreement is July 1, 2014, through June 30, 2015. This performance contract sets forth conditions and requirements that the County must meet in order to receive funding for the Mental Health Services Act (MHSA) programs; the Projects for Assistance in Transitions from Homelessness (PATH) program; and to provide community mental health services.

In prior years these agreements were made with the State Department of Mental Health (DMH); however, pursuant to the passage of AB102, DMH was dissolved. Under AB102, DHCS assumed the functions of DMH on July 1, 2012.

This Agreement specifies the requirements, conditions, and privacy safeguards under which Mariposa County Human Services must provide community mental health services and bill Medi-Cal for mental health services for Medi-Cal eligible recipients.

Mental Health Board Review:

On recurring contract renewals, the Mental Health Advisory Board has set direction that such contracts will be available for review by the Mental Health Advisory Board members and do not require individual approval unless there are changes in the provisions of the contract. This contract meets these criteria and is submitted to the Board of supervisors for a positive action.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The existing specialty mental health services Agreement (13-90316) was approved by the Board on October 22, 2013, Resolution 2013-472.

ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

Without this Agreement in place, Behavioral Health will be unable to receive MHSA and PATH

funding or to serve Medi-Cal beneficiaries and claim Medi-Cal reimbursement.

FINANCIAL IMPACT:


This is a Performance Agreement for services provided to Mental Health clients. There is no impact to the General Fund.
