RE: Notice of Completion for the Reconstruction of Ben Hur Road

RECOMMENDATION AND JUSTIFICATION:

Accept the Ben Hur Road Reconstruction Project as Complete and Authorize the Public Works Director to Record the Notice of Completion and Release the Retention. The work on Ben Hur has been completed by the contractor and the Public Works Director recommends acceptance of the project.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

On September 10, 2013, per Resolution 2013-389, the Board authorized Public Works to enter into an Agreement with Mark Stephens General Engineering Construction for the reconstruction of Ben Hur Road. On August 5, 2014, per Resolution No. 2014-395, the Board authorized a contract extension.

ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

Project would not be approved as complete and the department would be unable to release the retention to the contractor.


That on the 13th day of August, 2014, the contract as a whole, was actually completed by said Mark Stephens General Engineering Contractor.


