RECOMMENDED ACTION AND JUSTIFICATION: (Policy Item: Yes\_\_\_ No X)  
It is recommended the Board of Supervisors support an application by Self-Help Enterprises for a Housing Preservation Grant to be used in the County of Mariposa and other jurisdictions.

BACKGROUND AND HISTORY OF BOARD ACTIONS:  
Self-Help Enterprises, the nonprofit corporation currently administering the County's 1999 Community Development Block Grant (CDBG), intends to apply to USDA Rural Development for a Housing Preservation Grant (HPG) to be used in the County of Mariposa and other USDA-RD eligible communities. If granted, HPG funds used will augment and expand the County's 1999 CDBG housing rehabilitation project. If, in doing the rehabilitation work needed on a home, the cost exceeds the maximum loan amount allowed by CDBG, Self-Help Enterprises can offer the HPG funds to eligible households to complete the project. HPG funding can also be used to complete the weatherization of a home while CDBG is used to rehabilitate unsafe structural deterioration.

The grant application requests \$150,000 to benefit at least sixteen(16) qualified targeted income group households, with emphasis on the very low income. (Very low income, as defined in the California Department of Housing and Community Development Income Guidelines effective February 8, 1999 is set at \$18,350 annual income for a family of four in Mariposa County.) This application does not conflict with any County programs and is, in fact, designed to enhance the already awarded CDBG grant within the County of Mariposa by furthering the assistance available to County residents.

There is no cost to the County for application or implementation of the USDA-RD grant.

In order to include the County of Mariposa in Self-Help Enterprises' application, the Board of Supervisors must acknowledge support for the application at a regularly scheduled Board of Supervisors meeting. Evidence of support can be as recorded in the minutes or in a Resolution supporting the action.


