RECOMMENDED ACTION AND JUSTIFICATION: (Policy Item: Yes ___ No X)

Resolution Rejecting Proposals for the Landscaping Services Around County Facilities.

Public Works recommends that the Board reject the one proposal received for landscape services from Diversified Land and Waterscapes as the proposed sum for exceeds the available funds for the project.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The Board of Supervisors previously approved funding of \$20,000 for landscaping services as part of the FY 1999-00 budget.

On April 18, 2000, per Resolution No. 00-134, the Board approved the Request for Proposals for Landscape Services. Issuance of the proposal occurred on April 24, 2000 with a submittal deadline of May 31, 2000.

The one proposal that was received indicated \$78,670 for annual maintenance and \$40,076 for one-time improvements for a total of \$118,746.
