Resolution adopting bid and contract documents for the furnishing of a metal building for the Ponderosa Basin Fire Station, Public Works Project Number PW9803, and authorizing the Public Works Director to execute a contract with the selected building supplier.

Specifications for the metal building were prepared by the Engineering Division, based on a proposal obtained by Ponderosa Basin volunteers. Bids will be solicited from metal building suppliers for erections by volunteer labor. A copy of the specifications is attached. Bid opening is scheduled for Thursday, April 22. The Chowchilla Mountain Women's Club is the financing organization.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The Board of Supervisors has approved \$25,000 of funding for this project. Ponderosa Basin volunteers, through the Chowchilla Mountain Women's Club, are working to provide a fund match of this amount to provide for completion of the building, including engineering, foundation, insulation, doors, etc. Note that these specifications are for the materials for the bare metal shell.
