RECOMMENDED ACTION AND JUSTIFICATION:

(Policy Item: Yes \_\_\_ No X)

Discussion and direction regarding acceptance of relinquished right of way from Caltrans along Highway 140 for the planned sidewalk project in the town of Mariposa.

It is recommended by staff and Caltrans that the Board direct staff to draft the necessary agreement to allow Caltrans to relinquish a portion of their right of way to the County. The portion involved would be from the front edge of sidewalk (back of curb) to the existing edge of right of way behind the sidewalk. This will give the County the right and obligation to maintain the sidewalk and related planned improvements such as the trees and light fixtures.

The area of the proposed relinquishment is along the westerly side of Highway 140 as shown in yellow on the attached drawing. The only portion of the right of way not proposed to be included is near the intersection of Highway 49 North. This area has some existing improvements, including a large retaining wall, railing and slope which should remain under Caltrans control.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The Board has taken prior actions to fund the sidewalk project from grants and local funds and has authorized the project design/construction to proceed.

LIST ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

1. No action. The project could not proceed.
2. Accept the portion of the right of way near Highway 49 North. The County would also become responsible for non-related improvements.

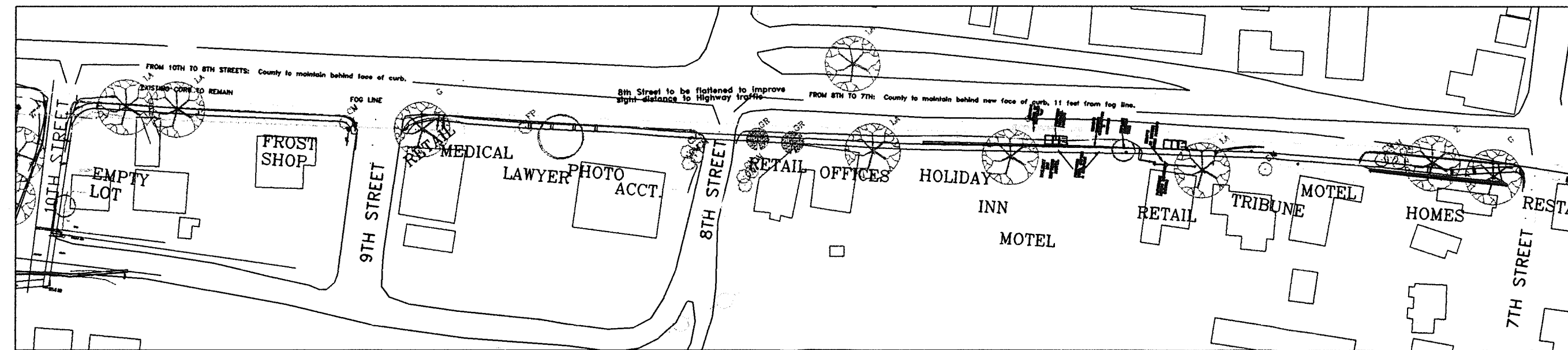
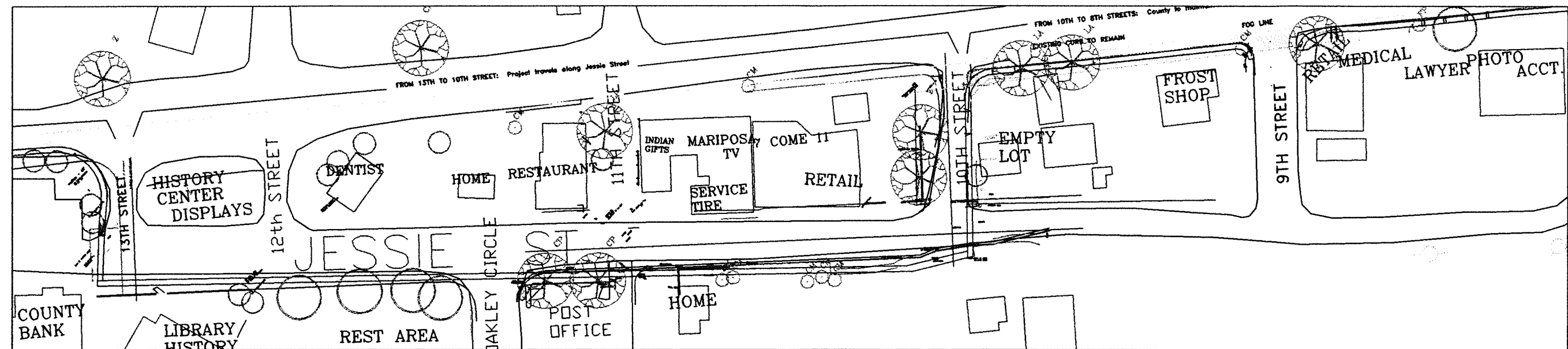
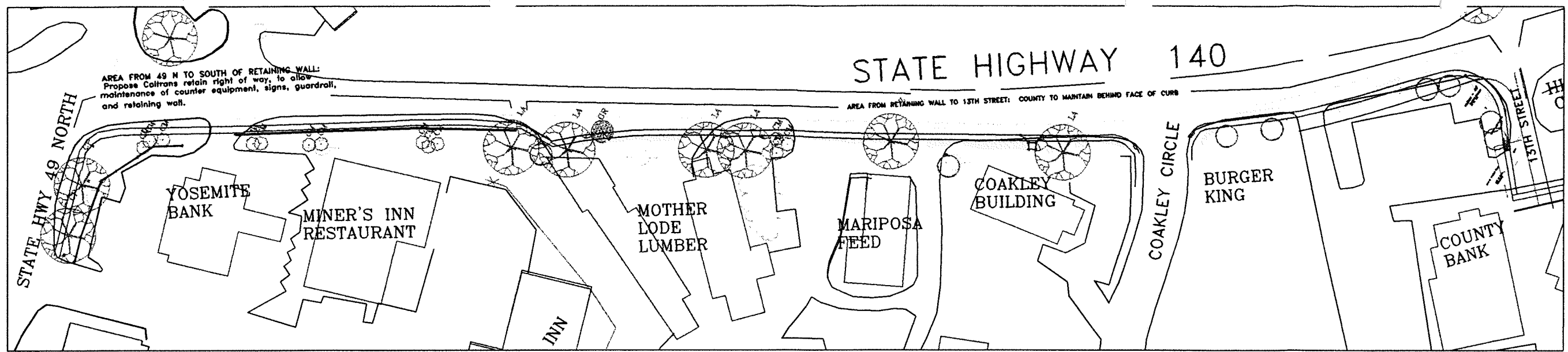

#### ACTION AND VOTE:

B) Discussion and Direction Regarding Acceptance of Relinquished Right of Way from CalTrans Along Highway 140 for the Planned Sidewalk Project in the Town of Mariposa

**BOARD ACTION:** Discussion was held with Mike Edwards regarding the planned sidewalk project for the town of Mariposa. Mike Edwards advised that the preferred process would be to gain the right of way from CalTrans along Highway 140 allowing the County long-term rights to the area to make improvements and repairs. He responded to questions from the Board relative to time frames and the permitting process. Phil Jones, CalTrans, provided input and advised of the opportunity to decrease the processing time, provided the County assists with the mapping. Mike Edwards advised that Public Works is willing to do this. Further discussion was held regarding the width of the proposed sidewalks and parking availability. (M)Parker, (S)Reilly, Res. 99-197 adopted directing the Public Works Director to begin the process for acceptance of relinquished right of way from CalTrans along Highway 140 in the town of Mariposa/Ayes: Unanimous.
