Request the Board Authorize the Sheriff to hire one Deputy Sheriff over what has been allocated in the 2000-2001 Sheriff's Budget. The department will be logging up to three Deputy Sheriff's to other departments within the next four months. The next Law Enforcement Academy starts January 2001, if we aren't allowed to hire and send a deputy to this academy the next available academy isn't until June 2001.

The County would be responsible for the salary of the deputy.

It is anticipated that this situation will end within three months and the department would return to what had been approved by the Board for the 2000-2001 Sheriff's Budget.

The Peace Officers Standards and Training (POST) Basic Police Academy is now six months.

The training is reimbursable from POST. The needed funds will be transferred from within the Sheriff's Budget.
