#### ACTION AND VOTE:

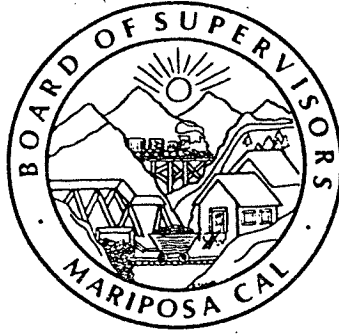

Discussion was held with Steve Hayes, Visitors' Bureau Director, and Bob Perez, Chamber of Commerce President, relative to the request. (M)Reilly, (S)Balmain, Board waived rules requiring 72 hours agenda noticing finding this is a matter of timeliness/Ayes: Unanimous. (M)Reilly, (S)Balmain, Res. 00-408 adopted authorizing the Mariposa County Road Commissioner to compose and sign a letter meeting the CalTrans requirements for the Merry Mountain Christmas Parade permit contingent upon the approval of County Counsel; authorizing the Chairman to sign a letter of support for the installation of the holiday banners; and authorizing the Road Commissioner to authorize the use of County roadways for temporary parade staging areas. Supervisor Stewart initiated discussion relative to the use of Third Street and whether there was a contingency plan to handle large vehicles and loads. Ayes: Unanimous.
