BACKGROUND AND HISTORY OF BOARD ACTIONS:

On Tuesday August 17, 2004 the Board of Supervisors approved an ordinance amending Chapter 9.20 Section 9.20.030 Subsection C of the Mariposa County Code prohibiting smoking in all county vehicles. During that presentation it was noted by Supervisor Balmain that Section 9.20.050 also needed amending. This amendment makes the entire Chapter consistent with prohibiting smoking in all county vehicles.

**MARIPOSA COUNTY
ORDINANCE NO. 1010**

**AN ORDINANCE AMENDING SECTION 9.20.050 OF
CHAPTER 9.20 OF THE MARIPOSA COUNTY CODE**

WHEREAS, the Board of Supervisors of the County of Mariposa desires to amend Section 9.20.050 of Chapter 9.20 to the Mariposa County Code; and

WHEREAS, amending Section 9.20.050 will prohibit smoking in all county vehicles;

NOW, THEREFORE, THE BOARD OF SUPERVISORS OF MARIPOSA COUNTY, a political subdivision of the State of California, does ordain as follows:

SECTION I:

9.20.050 Regulation of smoking in places of county employment and vehicles.

It shall be the responsibility of county department heads to provide a smoke-free workplace for all employees, including county-owned, rented and/or leased vehicles.

SECTION II: This Ordinance shall become effective thirty (30) days after final passage pursuant to Government Code Section 25123.
