

MARIPOSA COUNTY ORDINANCE No. 724

AN ORDINANCE AMENDING SECTIONS 2.36.020,
2.36.030, AND 2.36.040 OF CHAPTER 2.36 ENTITLED
"THE DEPARTMENT OF PUBLIC WORKS"
BY ADDING LANGUAGE RELEVANT TO
THE NEW "PARKS AND RECREATION DIVISION"

THE BOARD OF SUPERVISORS OF MARIPOSA COUNTY, a political subdivision of the State of California, does ordain as follows:

SECTION I: The Board of Supervisors of Mariposa County hereby adds the Parks and Recreation Division to the Department of Public Works by amending Section 2.36.020 entitled "Divisions" of Chapter 2.36 entitled Department of Public Works to read in its entirety as follows:

"2.36.020 Divisions. This department shall consist of the following divisions: road division, administration division, building/permits division, districts and facilities division, parks and recreation division, and engineer/surveyor division."

SECTION II: The Board of Supervisors of Mariposa County hereby reletters subsection "E" of Section 2.36.030 entitled "Responsibilities of each division" to letter "F", and hereby adds a new subsection "E" to read in its entirety as follows:

"E. The parks and recreation division shall be responsible for administering, operating and maintaining recreation and park facilities and programs, plan for the acquisition, development and operation of proposed recreation and park facilities in accordance with policies formulated by the board of recreation commissioners and approved by the board of supervisors, inform the general public of the services and facilities being provided by the parks and recreation division, assist community organizations in the promotion of recreation services. The public works director and/or deputy director, public works - parks and recreation division shall seek the advice of the board of recreation commissioners on recreation and parks matters."

SECTION III: The Board of Supervisors of Mariposa County hereby reletters subsection "E" of Section 2.36.040 entitled "Employees" to letter "F", and hereby adds a new subsection "E" to read in its entirety as follows:


"E. The parks and recreation division shall consist of one deputy director, public works - parks and recreation division, and such other employees as may be

provided by the board of supervisors."

SECTION IV: This ordinance shall become effective thirty (30) days from the date of final passage pursuant to California Government Code Section 25123.

SECTION V: Passed and adopted this 20th day of September, 1988 by the Board of Supervisors of Mariposa County by the following vote:




