

1 MARIPOSA COUNTY ORDINANCE NO. 614

2 AN ORDINANCE AMENDING THE ZONING MAPS
3 FOR THE UNCLASSIFIED AND AGRICULTURAL
4 EXCLUSIVE ZONES (Not to be codified in
Code Text)

5 WHEREAS, an application for change of zone was heard by the Pla-
6 nning Commission on a portion of property referred to as Assessor's
7 Parcel Number's 11-050-23, 11-260-001, 11-210-009, and a recommen-
8 dation by Planning Commission Resolution No. was made that the
9 application be granted, following a Public Hearing as required by
10 State Law; and

11 WHEREAS, a Public Hearing was held by the Board of Supervisors
12 after due notice as required by Law, and the application approved.

13 NOW THEREFORE, the Board of Supervisors of Mariposa County, a
14 political subdivision of the State of California, does hereby ordain
15 as follows:

16 SECTION I: Pursuant to Section 17.36.010 of the Mariposa County
17 Code, the Official Zoning Maps of the County of Mariposa shall be
18 amended to remove the following described properties from the Un-
19 classified Zone as established by Ordinance 345 and subsequent
20 amendments thereto, and to add said property to the Agricultural
21 Exclusive Zone as established by Ordinance 366 and amendments there-
22 to:

23 LEGAL DESCRIPTION: See Attached EXHIBIT A

24 SECTION II: This Ordinance shall take effect 30 days after the
25 date of passage pursuant to Government Code Section 25123.




