MARIPOSA COUNTY ORDINANCE NO. 554

AN ORDINANCE AMENDING SECTION 2.60.010 OF THE MARIPOSA COUNTY CODE ADDING A COST-OF-LIVING INCREASE TO THE SALARIES OF THE BOARD OF SUPERVISORS

WHEREAS the employees of the County of Mariposa have been granted a cost-of-living increase as of the beginning of the 1980-81 fiscal year; and

WHEREAS the elected officials of the County have, by ordinance, received the same cost-of-living increase; and

WHEREAS the Board of Supervisors has published notice and held a public hearing and received public comment generally favoring a similar cost-of-living increase for the Board itself;

NOW THEREFORE the Board of Supervisors of Mariposa County, a political subdivision of the State of California, does ordain as follows:

SECTION I: Mariposa County Code Section 2.60.010 is hereby amended to read in its entirety as follows:

"2.60.010 Designated. The annual salaries of the following county and district officers and employees are fixed as follows:

Assessor	\$21,780
Auditor/Recorder	21,780
Chairman, Board of Supervisors	13,200
Supervisor, Board of Supervisors	11,880
Constable	16,903
County Clerk	21,780
District Attorney	31,020
Mariposa Judicial Court Judge	21,780
Sheriff/Coroner	25,080
Treasurer/Tax Collector	21,780

The ten-percent cost-of-living salary increases covered by this amendment along with the salary adjustments shall be retroactive to July 1, 1979, and take effect in keeping with Government Code §§25123, 25123.5.

Beginning on July 1, 1980, and continuing thereafter until

1 changed by County Ordinance, all elected county and district
2 officers and employees described herein, except the Chairman
3 of the Board of Supervisors and the Supervisors, shall be paid
4 each month the sum of ONE HUNDRED AND SEVENTY-FIVE DOLLARS
5 (\$175.00) as a cost-of-living adjustment in addition to the
6 salary fixed herein for each such officer and employee; this
7 cost-of-living adjustment shall not be added to the schedule of
8 salary ranges nor shall it be considered as a merit increase or
9 step increase for any such officer or employee.

10 Beginning on December 8, 1980 and continuing thereafter
11 until changed by County Ordinance, the Chairman of the Board of
12 Supervisors and each Supervisor shall be paid each month the
13 sum of ONE HUNDRED AND SEVENTY-FIVE DOLLARS (\$175.00) as a
14 cost-of-living adjustment in addition to the salary fixed
15 herein for each such officer; this cost-of-living adjustment
16 shall not be added to the schedule of salaries set forth above."

17 SECTION II: This ordinance shall take effect and be
18 operative sixty days from the date of final passage pursuant to
19 California Constitution Article II Section 1 (b) and Government
20 Code Section 25123.5.
