MARIPOSA COUNTY ORDINANCE NO. 564

AN ORDINANCE AMENDING SECTION 2.60.010 OF THE MARIPOSA COUNTY CODE TO ADD A COST-OF-LIVING INCREASE FOR ELECTED OFFICIALS OF MARIPOSA COUNTY

THE BOARD OF SUPERVISORS of Mariposa County, a political sub-division of the State of California, does ordain as follows:

SECTION I: Chapter 2.60 of the Mariposa County Code is hereby amended to divide Section 2.60.010 into two sections with Section 2.60.010 to cover salaries of designated county and district officers, including elected officers of the county other than Supervisors, and Section 2.60.020 to cover salaries of Supervisors and the Chairman of the Board of Supervisors.

SECTION II: Section 2.60.010 of the Mariposa County Code is hereby amended to read as follows, in its entirety:

2.60.010 Designated. The annual salaries of the following county and district officers and employees are fixed as follows:

Assessor	\$ 25,074.00
Auditor/Recorder	25,074.00
Constable	19,953.00
County Clerk	25,074.00
District Attorney	34,776.00
Justice Court Judge, Mariposa	25,074.00
Sheriff/Coroner	28,539.00
Treasurer/Tax Collector	25,074.00

SECTION III: Section 2.60.020 of the Mariposa County Code is hereby added to set forth the salaries of members of the Board of Supervisors, which are not changed in amount by this ordinance, which shall read as follows:

"2.60.020 Board of Supervisors. The annual salaries of members of the Board of Supervisors are fixed as follows:

"Chairman, Board of Supervisors	\$ 13,200
Supervisor, Board of Supervisors	11,880

1 "Beginning on December 8, 1980, and continuing thereafter
2 until changed by county ordinance, the chairman of the board of su-
3 pervisors and each supervisor shall be paid each month the sum of
4 one hundred seventy-five dollars as a cost-of-living adjustment in
5 addition to the salary fixed herein for each such officer; this
6 cost-of-living adjustment shall not be added to the schedule of
7 salaries set forth above."

8 SECTION IV: The cost of living salary increases for desig-
9 nated officers and employees only, as set forth in Section II here-
10 in, shall be retroactive to July 1, 1981.


11 SECTION V: Pursuant to Government Code Section 25123, this
12 Ordinance shall take effect thirty (30) days from the date of final
13 passage.
