AN ORDINANCE AMENDING THE MARIPOSA COUNTY CODE CHAPTER 2.08 THERETO ENTITLED CONSOLIDATION OF OFFICES COPPECTING THE PREVIOUSLY ERRONEOUS CONSOLIDATION OF COUNTY CLERK AND AUDITOR-RECORDER AND ADOPTING PROVISIONS OF THE GOVERNMENT CODE REFERPED TO AS SECTION 25100.5

The Board of Supervisors of the County of Mariposa, State of California, does hereby ordain as follows:

- 2.08.020 Consolidation of District Attorney and Public Administrator, and Sheriff and Coroner.
- 2.08.030 The Clerk of the Board of Supervisors to be appointed by the Board of Supervisors
- 2.08.040 The office of County Clerk shall not be consolidated
- 2.08.050 The duties of the Clerk of the Board of Supervisors
- 2.08.010 Consolidation of Auditor-Recorder. The duties of the County Auditor-Recorder of the County of Mariposa are consolidated (Ord. 349, §5(a), 1972; Ord. 18 §1, 1886)
- 2.08.020 Consolidation of District Attorney and Public Administrator, and Sheriff and Coroner. Effective as of twelve noon on January 3, 1955, the Board of Supervisors elects to consolidate the officers of District Attorney and Public Administrator; and Sheriff and Coroner, pursuant to the provisions of Section 24300 of the Government Code of California. (Ord. 171 §1, 1954).
- the Board of Supervisors of the County of Mariposa pursuant to Section 25100.5 of the Government Code in the same manner as other county officers are appointed. The County Clerk shall not be the ex officio clerk of the Board of Supervisors. The Clerk of the Board of Supervisors shall perform those duties prescribed by law for the County Clerk as ex officio Clerk of the Board of Supervisors or for the Clerk of the Board of Supervisors and such additional duties as the Board of Supervisors shall prescribe. Such person may perform all the duties vested in the County Clerk excepting those duties vested in the County Clerk as ex officio clerk of the Superior Court or registrar of voters and may take acknowledgements and administer and certify oaths in the performance of such person's official duties.
- 2.08.040 The office of County Clerk shall not be consolidated with any other office and the duties of County Clerk shall be those duties set out in Government Code Section 26800 et seq excepting the position of ex officio clerk of the Board of Supervisors pursuant to the provisions of section

25100.5 of the Government Code.

2.08.050 The Clerk of the Board of Supervisors shall perform those duties prescribed in section 25101 et seq of the Government Code and such other additional duties as prescribed by the Board of Supervisors from time to time.

This Ordinance shall take effect on January 1, 1979.
