

ORDINANCE NO. 212

The Board of Supervisors of the County of Mariposa do ordain as follows:

SECTION 1. County Ordinance No. 174, known as the "Mariposa County Classification and Salary Ordinance", as amended, is hereby amended by adding to SECTION 8 the following 5 step Classifications, to wit:

SECTION 4. Said Ordinance is further amended by deleting paragraphs (f) and (i) of SECTION 10, and by inserting in lieu thereof the following respective paragraphs, to wit:

- (f) The judge of the Mariposa Judicial District Court shall receive a salary of \$5,200.00 per annum.
- (i) The Constable of the Coulterville Judicial District shall receive \$1,800.00 per annum.

SECTION 5. The effective date of this ordinance shall be Sep. 1, 1960.
