

ORDINANCE NO. 160

The Board of Supervisors of the County of Mariposa, do ordain as follows:

SECTION 1. The County of Mariposa is hereby divided into Judicial districts.

SECTION 2. Between January 1, 1952 and twelve o'clock Noon January 4, 1955, there shall be six judicial districts, which are hereby established and named as follows:

- A. Hornitos Judicial District
- B. Coulterville Judicial District
- C. Cathay Judicial District
- D. Mariposa Judicial District
- E. Oakvale Judicial District
- F. El Portal Judicial District

SECTION 3. The Hornitos Judicial District hereby established shall consist of all that part of the County of Mariposa lying within the boundaries of the Number One Supervisorial District.

SECTION 4. The Coulterville Judicial District hereby established shall consist of all that part of the County of Mariposa lying within the boundaries of the Number Two Supervisorial District.

SECTION 5. The Cathay Judicial District hereby established shall consist of all that part of the County of Mariposa lying within the boundaries of the Number Three Supervisorial District.

SECTION 6. The Mariposa Judicial District hereby established shall consist of all that part of the County of Mariposa lying within the boundaries of the Number Four Supervisorial District.

SECTION 7. The Oakvale Judicial District hereby established shall consist of all that part of the County of Mariposa lying within the boundaries of the Number Five Supervisorial District, except the El Portal and Yosemite East and Yosemite West  
/ Election precincts.

SECTION 8. The El Portal Judicial District hereby established shall consist of all that part of the County of Mariposa lying within

the boundaries of the El Portal, Yosemite East and Yosemite West Election Precinct.

SECTION 9. After twelve o'clock Noon January 4, 1955, there shall be two Judicial Districts, which are hereby established and named as follows:

- a. Coulterville Judicial District
- b. Mariposa Judicial District

SECTION 10. After twelve o'clock Noon January 4, 1955, the Coulterville Judicial District shall consist of all that part of the County of Mariposa lying North of a line parallel to and one mile North of the Merced River.

SECTION 11. After twelve o'clock Noon January 4, 1955, the Mariposa Judicial District shall consist of all that part of the County of Mariposa not within the boundaries of the Coulterville Judicial District.
