RE: Transfer Funds Within the Solid Waste Budget

## RECOMMENDATION AND JUSTIFICATION:

Approve Budget Action Transferring Fund Within the Solid Waste Budget to Account for Expenses Related to a Fixed Asset Purchase Being Greater than Originally Estimated (\$1,093). The transfer will provide sufficient funding to mitigate a category level negative balance and will not negatively affect the Solid Waste budget. Costs associated with the Fork Lift and Yard Ramp (a fixed asset) were greater than estimated and there are savings in the Major Vehicle Repair line item that can be used to offset this expense without negatively impacting the operations of Solid Waste. This transfer of funding is needed in order to pay a vendor and thus should not be delayed until mid-year budget adjustments.

#### BACKGROUND AND HISTORY OF BOARD ACTIONS:

Budget actions that transfer funding between categories (services/supplies and fixed assets) in a budget unit, require Board approval. The Board has routinely approved budget actions of this type.

# ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

If the Board does not approve the transfer payment of the vendor will be delayed.

#### FINANCIAL IMPACT:

Funding of \$1,093 will be transferred between the Major Vehicle Repair line item and the Fork Lift and Yard Ramp line item.
