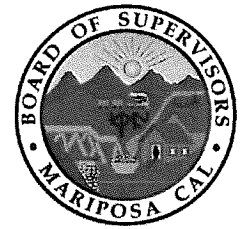

RE: Legislative Platform 2016

RECOMMENDATION AND JUSTIFICATION:

Discussion and Possible Approval of the County's 2016 Legislative Platform. The Legislative Platform is the County Board of Supervisor's declaration of issues and items that are of importance to the citizens of the County. By identifying priorities, the Platform helps guide this office and County departments in recommending legislative positions. The Platform also provides the County Administrative Officer with direction as to the County's position in those instances when a timely response is necessary. This year's Platform addresses thirteen broad topics ranging from service delivery and funding equity to tree mortality and environmental concerns.

The Board annually develops and approves a legislative platform.
