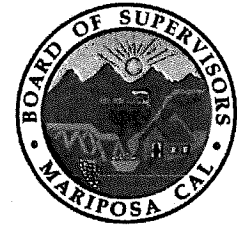

RE: Approve FY 2016/2017 Nursery Inspection Cooperative Agreement #16-0292-SA

RECOMMENDATION AND JUSTIFICATION:

Approve Nursery Inspection Cooperative Agreement No. 16-0292-SA for Fiscal Year 2016/2017 with the California Department of Food and Agriculture (CDFA); and Authorize the Board of Supervisors Chair to Sign the Agreement.

This cooperative agreement provides State subvention funds for work performed in Mariposa County in nursery inspection and licensing. There is no change in the cooperative agreement or subvention amount from previous cooperative agreements. The total available Fiscal Year 2016/2017 subvention amount for this nursery inspection cooperative agreement is \$500.

Last year's cooperative agreement was approved by Resolution No. 15-351.
