RE: Onsite Wastewater Treatment Systems Local Area Management Plan

RECOMMENDATION AND JUSTIFICATION: Approve Environmental Health Manager to Submit the Onsite Wastewater Treatment Systems Local Area Management Plan for Mariposa County to the Central Valley Regional Water Quality Control Board.

The attached LAMP document describes how Mariposa County handles on-site sewage disposal using existing County Codes, Rules and Regulations pursuant to County Code and Health Department Policies that have been developed over the past 25 years.

BACKGROUND AND HISTORY OF BOARD ACTIONS: No previous Board Actions. In 1990 AB885 was passed by the State Legislature requiring statewide sewage disposal regulations to be adopted. In 2013 the State Water Board adopted a Water Board Policy in place of regulations that is far more restrictive than Mariposa Counties Sewage Disposal Rules and Regulations. The policy allows Counties to submit a Local Area Management Plan (LAMP) that describes how sewage disposal will be handled differently than the prescriptive standards in tier 1 of the policy but still be protective of the State's Waters.

ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

Do not approve submittal of the LAMP and The County will have to begin following the prescriptive standards in tier 1 of the policy starting May 13, 2018.
