BACKGROUND AND HISTORY OF BOARD ACTIONS:

Advertising for bids is made per Mariposa County Ordinance No. 761, which requires notice to the Board of the proposed time and place of the opening of bids.

Per Resolution 94-09, the Board awarded the present County contract to Pro-Flame Gas Company for the period of January 1, 1994, to June 30, 1995. Per Resolution 95-182 the contract was extended through August 1995 to accommodate the County application to tag on to the State contract for L.P. fuel.
