**RECOMMENDED ACTION AND JUSTIFICATION:** That the Board pass a resolution declaring elected those candidates nominated to the Democratic and Republican County Central Committees, pursuant to Elections Code Sections 8873 and 9373, respectively, as follows:

Democratic Central Committee

District One - Ernest S. Correa, Carol P. Davis, and Reba F. Morse.

Republican Central Committee

District Three - Frank L. Long, Jr., Virgil N. Mullis, and Mary Ann Visher.

District Four - Zella K. Hendryx.

District Five - J. C. Burris, Hazel P. Eickworth, Jeffrey W. Lincoln, and Bradford D. Murphy.

**BACKGROUND AND HISTORY OF BOARD ACTIONS:** The Election Code states that, if the number of candidates nominated to the County Central Committees does not exceed the number of candidates to be elected and a petition signed by 25 registered voters affiliated with the political party has not been filed within 20 days after the final date of filing for the position, then the names of nominees shall not be printed on the party's ballot and those candidates nominated shall be declared elected. The criteria set forth in the Elections Code have been met.

**LIST ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:** If the Board does not declare these nominees elected, the County Central Committees would have no members beginning January 1991.
