MARIPOSA COUNTY RESOLUTION NO. 90-307

REGARDING THE DISABILITY RETIREMENT  
OF KARLA K. ASHTON  
FROM THE COUNTY OF MARIPOSA  
PUBLIC EMPLOYEES' RETIREMENT SYSTEM

WHEREAS, the County of Mariposa (hereinafter referred to as "AGENCY") is a contracting agency of the Public Employees' Retirement System, and

WHEREAS, the Public Employees' Retirement Law requires that a contracting agency determine whether an employee of such agency in employment in which he is classified as a local safety member is disabled for purposes of the Public Employees' Retirement Law and whether such disability is "industrial" within the meaning of such Law, and

WHEREAS, an application for disability retirement of KARLA K. ASHTON employed by AGENCY in the position of Deputy Sheriff has been filed with the Public Employees' Retirement System, and

WHEREAS, the Mariposa County Board of Supervisors has reviewed the medical and other evidence relevant to such alleged disability and determined that the disability was due to stress;

NOW THEREFORE, BE IT RESOLVED:

1. That the Mariposa County Board of Supervisors, finds and determines and it does hereby find and determine that KARLA K. ASHTON is incapacitated within the meaning of the Public Employees' Retirement Law for performance of her duties in the position of Deputy Sheriff, and that her condition was determined to be permanent and stationary as of January 17, 1990, and


2. BE IT FURTHER RESOLVED that the Mariposa County Board of Supervisors, find and determines and it does hereby find and determine that such disability is a result of stress arising out of and in the course of employment; and further determines that such disability did not result from an injury which is the direct consequence of a violent act perpetrated upon the member or did not occur during the performance of those portions of the member's duties which are particularly hazardous and dangerous, and neither said KARLA K. ASHTON nor the AGENCY, County of Mariposa, has applied to the Workers' Compensation Appeals Board for a determination pursuant to Section 21026 whether such disability is industrial.

3. BE IT FURTHER RESOLVED that the effective date of disability retirement for Karla K. Ashton shall be April 18, 1990.


