RECOMMENDED ACTION AND JUSTIFICATION:

Public Works recommends that the Board of Supervisors direct County Council to draft an amendment to the contract with Total Waste Systems (TWS) for the operation of the landfill. Public Works suggests waiving the requirement for a performance bond in lieu of which TWS will provide the County with expanded recycling services as detailed on the attached sheet.

Under our current contract the recycling services rendered to the County were basic and mainly addressed recyclable types of materials that fall within the California Bottle Bill. However, our agreement stops short of providing a certified redemption center. This enhancement to the program would provide the public with the new service of being able to be paid for their recyclables at the landfill. This would be helpful in motivating the County's residents to recycle.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

TWS has just assumed the recycling at the landfill under their present contract. Previously the contract was with Mother Lode Recycling.
