RECOMMENDED ACTION AND JUSTIFICATION:

Recommend resolution authorizing Chairman to sign State Standard Agreement for Automated Medically Indigent Care Reporting System; recommend resolution establishing the position of Account Clerk I/II at the Health Department; recommend appropriation of \$4,233 for costs related to administration of Rural Health Services funds. The Health Officer applied for this grant to help with the administrative burden associated with Prop 99 funds. We will be administering these funds every year. Also, with the advent of fees, accounting has become more complicated in the Health Department. To manage all the accounting in the office, a full time Account Clerk is needed. Funding this position in future years will come from the Prop 99/RHS funds themselves (10% may be used for administration), and from SB - 12 funds for EMS related expenses, and from fees revenues (which this fiscal year budgeted for a new vehicle).

Pass and adopt this resolution amending the Employee Allocation Schedule to: add position of Account Clerk I/II, at range 114-130, effective 12/11/90.

Resolution No. 90-591 is amended and superseded in its entirety and Employee Allocation Schedule, Exhibit A-186, together with Schedule of Salary Ranges Exhibit C-1 and D-1 are attached hereto by this reference.
