RE: Waive Encroachment Permit Fee for the Indian Gulch Run in Hornitos

#### RECOMMENDATION AND JUSTIFICATION:

Authorize Public Works to Waive the Encroachment Permit Fee of \$140 for the 42nd Annual Indian Gulch Run in Hornitos on March 25, 2018.

This event will be held in Hornitos with the start/stop location at the Hornitos Park, and will provide two mile, five mile, and ten mile courses. Additionally, Hornitos 4-H will be hosting a breakfast, and the race proceeds will benefit the cross country running team of Buhach Colony High School in Merced.

#### **BACKGROUND AND HISTORY OF BOARD ACTIONS:**

The Board has waived encroachment permit fees for this and other events in the past.

#### ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

Do not authorize Public Works department to waive the encroachment permit fee. The event organizers will need to pay for the encroachment permit fee, which may cause a hardship since the event is being sponsored by volunteers and it is not intended to be a money making event.

This is a well managed event presented by the Merced Running Club in Merced, CA. This year myself, Gordon Wilkinson, and Al Garcia are Co-Race Directors.

The Merced Running Club is a non-profit organization and profits from our races eventually find their way back into the running community.

<u>Second</u> is a map of the course that we use each year. The race starts and finishes on High Street. The run start on High Street then turns south onto Hornitos Road. The two mile event turns around on Hornitos Road. The five and ten mile races continue onto Indian Gulch Road. The turnarounds are shown on the map.

For safety, there will Runner on the Road signs on Hornitos Road on each side of High Street and on each side of Indian Gulch Road. There will also be two course monitors at each intersection. There will also be a Runners on the Road sign on Indian gulch Road prior to the 10 mile turnaround.


Additionally, there will be a water station at both the 5 mile and 10 mile turnarounds.


