

MARIPOSA COUNTY RESOLUTION NO. 85-76

A RESOLUTION TO AMEND THE SALARY RESOLUTION
RELATIVE TO THE AUDITOR/RECORDER SECTION
OF EMPLOYEE ALLOCATION SCHEDULE

WHEREAS, the Auditor/Recorder, Evelyn Billings, has requested a full time position in place of the position presently allocated 75% Auditor and 25% Tax Collector, and

WHEREAS, the Board of Supervisors desires to accept the recommendation of the Department head and adjust the Employee Allocation Schedule to reflect these changes.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors, a political subdivision of the State of California as follows:

1. Page 1, Section C, entitled AUDITOR/RECORDER of the Employee Allocation Schedule shall delete:

1 Deputy Auditor (75%) Tax Collector (25%) 110-126

and add:

1 Deputy Auditor 110-126

2. Resolution No. 84-319 is hereby amended and superseded in its entirety.




