18 Act Contract subject to the conditions set forth in Mariposa  
19 County Resolution 82-265, and

21 all conditions set forth in Mariposa County Resolution No. 82-265  
22 have been complied with,

23 BE IT THEREFORE RESOLVED, that the Mariposa County Board  
24 of Supervisors hereby acts to cancel that portion of Williamson  
25 Act Contract No. 23 which affects the property described in  
26 Attachment "A".






