6 WHEREAS, the Board of Supervisors of Mariposa
7 County, a political subdivision of the State of California
8 desires to extend the Agreement with Phinas Orb Hatton for
9 personal services entered into on May 20, 1985, and
10 terminating August 20, 1985, and

11 WHEREAS, Phinas Orb Hatton desires to continue to
12 provide specialized professional services to the Mariposa
13 County Sheriff's Department as outlined in said Agreement,
14 and

15 WHEREAS, Paragraph 1 contains the terms relative to
16 the length of employment, and

17 WHEREAS, Paragraph 6, should be amended to replace
18 Ken Matthys, Sheriff with Tom Strickland, Acting Sheriff, and

19 WHEREAS, Acting Sheriff Tom Strickland has respect-
20 fully requested from the Board of Supervisors that the original
21 Agreement with Mr. Hatton be further extended for a period of
22 not more than thirty (30) days;

23 NOW THEREFORE, BE IT RESOLVED by the Board of Super-
24 visors of Mariposa County as follows:

25 1. Both Parties of the above-described Agreement
26 hereby agree to extend the term of said Agreement on a day-to-
27 day basis on the same terms and conditions as the original
28 Agreement entered into by and between the Parties, commencing
August 21, 1985 and terminating September 20, 1985 unless

terminated earlier as provided for below.

2. The Agreement by and between County of Mariposa and Mr. Hatton may be terminated at any time by the Sheriff or Acting Sheriff upon twenty-four (24) hours written notice to Mr. Hatton commencing August 21, 1985. In no event shall the Agreement extend beyond September 20, 1985.

3. All of the terms and conditions of the original Agreement and the resolution adopted July 9, 1985 as Resolution No. 85-223 shall remain in full force and effect throughout the period of this extension.

8 Agreement and the resolution adopted July 9, 1985 as Resolution
9 No. 85-223 shall remain in full force and effect throughout the
10 period of this extension.
