

1 MARIPOSA COUNTY RESOLUTION NO. 85-274

2 A RESOLUTION RELATIVE TO THE PURCHASING AGENT
3 PURCHASING OFFICE EQUIPMENT AND VEHICLES FOR DEPARTMENTS

4 WHEREAS, various County Departments have presented requests to the
5 Board of Supervisors for upgrading and replacing equipment, and

6 WHEREAS, the Board of Supervisors desires to accommodate those
7 Departments with the most pressing needs, and

8 WHEREAS, it is in the public's best interest that the items not be
9 formally bid.

10 NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of
11 Mariposa County, a political subdivision of the State of California, that
12 the Mariposa County Purchasing Agent, the Chairman of the Board, is hereby
13 authorized to receive proposals, select the best possible price, and purchase
14 for and on behalf of the County the following items:

15 A. Typewriters:

- 16 1. Two (2) typewriters for County Clerk, cost
17 not to exceed \$1,692.00.
- 18 2. One (1) typewriter for Auditor/Recorder, cost
19 not to exceed \$850.00.
- 20 3. Two (2) typewriters for Justice Court, cost
21 not to exceed \$2,000.00.
- 22 4. One (1) typewriter for Public Health Office,
23 cost not to exceed \$505.00.
- 24 5. Three (3) typewriters for Welfare & Security,
25 cost not to exceed \$3,000.00.

26 B. Calculators:

- 27 1. One (1) calculator for Auditor/Recorder, cost
28 not to exceed \$200.00.
- 29 2. Three (3) calculators for Welfare & Security,
cost not to exceed \$240.00.

- 4 1. One (1) chair for Auditor/Recorder, cost not
5 to exceed \$175.00.
6 2. One (1) secretarial chair for Public Health Office,
7 cost not to exceed \$100.00.
8 3. Two (2) secretarial chairs for Welfare & Security,
9 cost not to exceed \$220.00.
4. Two (2) executive chairs for Welfare & Security,
cost not to exceed \$400.00.

10 D. Typewriter stands:

- 11 1. One (1) typewriter stand for Auditor/Recorder, cost
12 not to exceed \$150.00.
13 2. One (1) typewriter stand for Public Health Office,
14 cost not to exceed \$90.00.

15 E. Business Processors:

- 16 1. One (1) business processor for County Counsel, cost
17 not to exceed \$6,000.00.
18 2. One (1) business processor for District Attorney,
19 cost not to exceed \$6,000.00.

20 F. Automobiles:

- 21 1. Six (6) automobiles for Sheriff/Coroner, cost not
22 to exceed \$25,775.00.
23 2. One (1) automobile for Constable, cost not to exceed
24 \$14,800.00.
25 3. One (1) mid-size pickup for Solid Waste, cost not to
26 exceed \$8,500.00.
27 4. One (1) mid-size pickup for Special Districts Manager,
28 cost not to exceed \$8,500.00.

G. Radios:

1. One (1) radio for Blazer for Building Department,
cost not to exceed \$848.00.

- 12 1. One (1) VCR and TV with stand for Welfare & Security,
13 cost not to exceed \$1,000.00.

14 K. Computer:

- 15 1. One (1) computer for Welfare & Security, cost not
to exceed \$7,500.00.


16 L. Dictaphone and Recorder:


