A RESOLUTION FOR THE RETURN OF CONFIDENTIAL FUNDS FROM PHINAS ORB HATTON

WHEREAS, Mr. Phinas Orb Hatton entered into an agreement with Mariposa County to provide services to the Sheriff's Department; and

WHEREAS pursuant to the contract with the County Confidential Funds were turned over to Mr. Hatton; and

WHEREAS Mr. Hatton has failed to properly account for and/or return a portion of said Confidential Funds,


NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Mariposa County, a political subdivision of the State of California, County Counsel is hereby directed to communicate with Mr. Phinas Orb Hatton and make a formal demand for either a complete accounting or return of Confidential Funds which were turned over to Mr. Hatton pursuant to his contract with Mariposa County, within ten days of County Counsel's letter. The Board further directs that if the formal accounting or return of funds is not made within the ten days, County Counsel is to see that appropriate legal action for the accounting or return of funds is taken.



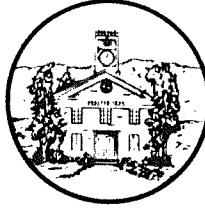


RE: Confidential Funds

Dear Mr. Hatton:

As you know, Acting Sheriff Tom Strickland has, on numerous occasions, both orally and in writing requested from you a detailed accounting of the Confidential Funds which you received in your position as a contract employee of the County. It is my understanding that the sum of One Thousand Four Hundred Forty-Five Dollars still remains totally unaccounted for. In that regard, the Board of Supervisors, on Tuesday, October 8, 1985, adopted Resolution No. 85-314 directing Counsel's Office to make a formal demand upon you for either a complete accounting of those funds or a return thereof.

Therefore, please consider this letter a formal demand upon you to provide to the satisfaction of Acting Sheriff Tom Strickland a complete accounting of the unaccounted for sums, or a return of those funds on or before October 21, 1985. If you have failed to provide the accounting to the satisfaction of Acting Sheriff Tom Strickland or the return of the funds unaccounted for, on or before Monday, October 21, 1985, the County will institute legal proceedings regarding this matter.
