A RESOLUTION WAIVING THE FORMAL BIDDING PROCEDURE
FOR THE PURCHASE OF DICTAPHONE TELEPHONE AND RADIO RECORDING
EQUIPMENT AT THE MARIPOSA COUNTY JAIL

WHEREAS, the Sheriff's Department has requested the authority to purchase a telephone-radio recording device; and

WHEREAS, the Sheriff's Department has consulted with several potential suppliers of this type of equipment and determined that the Dictaphone unit best meets the needs of the County, based on Dictaphone's servicing capabilities, purchase price, and customer satisfaction; and

WHEREAS, there is an immediate need for this type of equipment;


NOW, THEREFORE, BE IT RESOLVED by the Mariposa of Supervisors of Mariposa County, a political subdivision of the State of California, that the Board finds it in the best public interest to waive the formal bidding procedures for the purchase and installation of a Dictaphone telephone and radio recording device in the amount of \$23,584.26; with the letter from the Sheriff's Department dated November 18, 1985, to be attached as findings and justification for said waiver.

RE: TAPE LOGGER PURCHASE

Dear Honorable Members of the Board:

The Sheriff's Department is requesting authorization to waive the formal bid process in the best interest of the county. This is in order that we may immediately purchase and install a telephone and radio recording device.

I have contacted both Dictaphone Company and Magsync Moviola Company. These are the only two manufacturers of this type of equipment on the west coast. Both companies provide the same equipment at approximately the same price. After consideration and study of each company's equipment, it is my opinion that the county would best be served by the purchase of the Dictaphone Company's unit.

Pricewise, installed with a one-year service contract, Magsync quotes \$24,762.00 and Dictaphone quotes \$22,249.30 (less sales tax). In addition I contacted an adjoining county which is using the Magsync Moviola unit and they have not been satisfied with the performance and/or service of the unit.

Therefore, I hereby respectfully request the Board of Supervisors authorize the Sheriff's Department to purchase the Dictaphone unit at a total cost of \$23,584.26.
