**RECOMMENDATION AND JUSTIFICATION:** Accept the Mariposa County General Plan Strategic Implementation Work Plan.

This recommendation is based upon the Board of Supervisors' and Planning Commission's discussion and recommendations made during a Final Joint Workshop (3) conducted on February 14, 2018. Refinements were made to the draft plan by the consultant, following this workshop, and are reflected in the attached final work plan.

Staff will use this plan to guide development of the department's annual work priorities, to discuss identified tasks with other responsible county departments, and to request funding during County's annual budget process.

### **BACKGROUND AND HISTORY OF BOARD ACTIONS:**

The Board of Supervisors initiated a project to develop a General Plan Implementation Program; a strategic program to guide successful completion of General Plan Implementation Measures.

The Mariposa County General Plan Strategic Implementation Work Plan presented for the Board's acceptance was prepared, using consultant assistance, as a result of:

1. Review of General Plan Implementation Measures, as established in 2006, including status of completion or implementation;
2. Review of input from the Planning Commission workshop on October 6, 2017, regarding priorities and concerns;
3. Review of input from the Board of Supervisors workshop on November 14, 2017, regarding priorities and concerns;
4. Consideration of emerging local issues and state legislation approved since 2006;
5. Proposed logical groupings of implementation measures which have not yet been completed;

6. Review of input from the Planning Commission workshop on December 15, 2017, regarding Task 2.4;

7. Review of input from the Board of Supervisors workshop on January 17, 2018, regarding Task 2.4; and

8. Review of input from a Joint Planning Commission and Board of Supervisors workshop on February 14, 2018.

### **ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:**

Alternatives: Make further amendments to Work Plan.

Negative action or not accepting the Work Plan could result in a continued fragmented approach to General Plan implementation.
