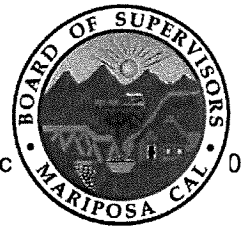

RE: First Amendment Kings View Corp. Agreement with Behavioral Health
(Telepsychiatry Services)

RECOMMENDATION AND JUSTIFICATION:

Approve Amendment to Agreement with Kings View Corporation to provide telepsychiatry services for Mariposa County Behavioral Health in an amount not to exceed \$291,600; and authorize the Board of Supervisors Chair to sign the Amendment.

This amendment clarifies the start date of the term of the existing agreement, ensuring full compensation of services provided.

Telepsychiatric Services are necessary to allow the County to address cultural, socioeconomic and geographic barriers to behavioral health services in the underserved area of Mariposa County. Telepsychiatrists often prescribe the psychiatric medications needed by clients. This contract will allow Behavioral Health to expand the range of resources and services available within the County in an efficient and cost effective manner.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The existing agreement for telepsychiatry was approved by the Board on October 17, 2017 by Resolution 2017-712.

ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

The reliable services of this provider would not be available to meet client telepsychiatry needs.

FINANCIAL IMPACT:

This Amendment only clarifies the term start date and adds no additional cost to the existing Agreement. The not to exceed amount of the contract is \$291,600. The cost of this agreement is spread over the Mental Health 001-0402 and Mental Health Services Act 410 budget units and is incorporated in the FY17-18 budget. There is no impact on the General Fund.

FIRST AMENDMENT TO AGREEMENT FOR TELEPSYCHIATRY SERVICES

THIS FIRST AMENDMENT TO AGREEMENT FOR TELEPSYCHIATRY SERVICES is made and entered into this 17th day of April, 2018, by and between the County of Mariposa, a political subdivision of the State of California, hereinafter referred to as "**County**", and Kings View Corporation, hereinafter referred to as "**Contractor**".

WHEREAS, **County** and **Contractor** have heretofore entered into a Contract dated October 17, 2017, wherein **Contractor** agreed to provide telepsychiatry services; and

WHEREAS, **County** and **Contractor** desire to amend said Contract to change the effective date to be provided to **Contractor**;


NOW, THEREFORE, the parties hereto in consideration of the mutual covenants herein recited, hereby agree as follows:

1. Page 2, Paragraph 3 "TERM", is hereby amended as follows: "The term of this Agreement shall commence on July 1, 2017 and shall continue in full force and effect through June 30, 2018 subject to the termination as provided in this Agreement."
2. Except as herein amended, the agreement dated October 17, 2017 shall remain in full force and effect.


