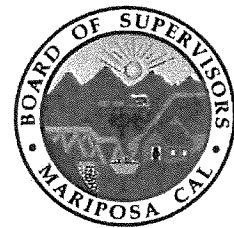

TO: The Board of Supervisors

RE: First Amendment - Agreement with Berliner-Cohen Attorneys at Law

RECOMMENDATION AND JUSTIFICATION:

Approve First Amendment to Agreement with Berliner-Cohen Attorneys at Law, increasing the amount by \$20,000 to an amount not to exceed \$80,000; and authorize the Board of Supervisors Chair to sign the Amendment.

In past years, County Counsel's office provided much of these services. Due to workload and availability, it was determined that a direct contract with Berliner-Cohen would benefit Human Services. Berliner-Cohen will provide legal services in juvenile dependency and public guardian/conservatorship cases. County Counsel will determine when it is necessary for Berliner-Cohen to act for the Human Services Department in Child Welfare cases and any other matter County Counsel deems appropriate. During this current agreement, the amount of required services proved to be greater than anticipated.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

Mariposa County has an existing agreement with Berliner-Cohen, approved through Resolution No. 2017-355 on June 6, 2017.

ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

If this contract is not approved, the workload for the County Counsel's office may be such that it creates process delays.

FINANCIAL IMPACT:

**There is sufficient funding in the Social Services Budget to fund this Agreement.
There is no impact to the County General Fund.**

FIRST AMENDMENT TO AGREEMENT FOR LEGAL SERVICES

THIS FIRST AMENDMENT TO AGREEMENT FOR LEGAL SERVICES is made and entered into this 7th day of August, 2018, by and between the County of Mariposa, a political subdivision of the State of California, hereinafter referred to as "**County**," and Berliner-Cohen Attorneys At Law, hereinafter referred to as "**Contractor**."

WHEREAS, County and Contractor have heretofore entered into an Agreement dated June 6, 2017, wherein **Contractor** agreed to provide legal services; and

WHEREAS, County and Contractor desire to amend said Agreement to change the compensation to be provided to **Contractor**;

NOW, THEREFORE, the parties hereto in consideration of the mutual covenants herein recited, hereby agree as follows:

1. Paragraph 3.0, "COMPENSATION", is hereby amended to provide that an additional \$20,000 will be added to the original amount of \$60,000, making the total compensation paid to **Contractor** the not to exceed amount of \$80,000.

2. Except as herein amended, the agreement dated June 6, 2017 shall remain in full force and effect.
