**A resolution recommending that the Board of Supervisors accept the 2018 General Plan Annual Report and approve the 2018 Schedule of General Plan Amendments, County Project No. 2018-111**

**WHEREAS**, the laws of the State of California require Mariposa County to adopt and maintain a General Plan to guide the long-term development of the County, pursuant to Government Code Section 65300 et seq.; and

**WHEREAS**, State Government Code Section 65400(a)(2) requires that an annual report be prepared on the progress in the implementation of the General Plan, and the progress the County is making with regard to meeting its share of regional housing needs; and

**WHEREAS**, a draft 2018 General Plan Annual Report was prepared in accordance with the requirements of the State law, and was made available for public review; and

**WHEREAS**, a duly noticed Planning Commission public hearing and workshop on the 2018 General Plan Annual Report was scheduled for the 15<sup>th</sup> day of June, 2018; and

**WHEREAS**, the Planning Commission did hold a public hearing and workshop on June 15, 2018 and considered the information provided by County Departments and in the public record, including the 2018 General Plan Annual Report.

**NOW THEREFORE, BE IT RESOLVED THAT**, the Planning Commission of the County of Mariposa does hereby recommend that the Board of Supervisors accept the 2018 General Plan Annual Report, and approve the 2018 Schedule of General Plan Amendments as shown in Exhibit A; and forward it to the State Department of Housing and Community Development and the State Office of Planning and Research. The Planning Commission recommends the Board find these actions are categorically exempt from environmental review
