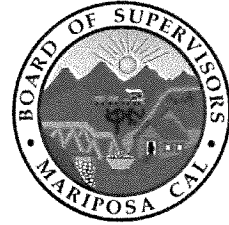

## **RESOLUTION - ACTION REQUESTED 2018-523**

RE: Approve Fiscal Year 18-19 Budget Adjustment to Include Previously Omitted Funds 427 and 524

---

### **RECOMMENDATION AND JUSTIFICATION:**

Approve Fiscal Year 18-19 Budget Adjustment to Include Previously Omitted Funds 427 Prop 56 Tobacco Tax Funding (\$168,270) and 524 February 2017 Storm Damage Repair Funding (\$174,124).

Fund 427 was established to track Proposition 56 health funding. Fund 524 was established to track February 2017 storm state and federal funding to offset expenditures associated with damages caused by that flood event.

Anticipated funding and associated expenditures were not included in the approved FY19 budget for these two funds, so this budget action corrects an error which allows the County to receive and process funds which have already been obtained but cannot be acknowledged and spent until this budget action is approved amending the FY19 budget.

### **BACKGROUND AND HISTORY OF BOARD ACTIONS:**

The Board adopted Resolution 18-295 on June 26, 2018, adopting the Fiscal Year 2018-19 Budget.

The Board adopted Resolution 18-516 on October 23, 2018 adopting balancing adjustments for FY19 budget.

### **ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:**

Failure to approve this budget action would make it impossible for Mariposa County to recognize state and federal funding associated with these two fund accounts and to process expenditures associated with the same.
