### **RECOMMENDATION AND JUSTIFICATION:**

Reappoint Mick Herman as Planning Commissioner for District III for a term coinciding with the term of District III Supervisor Marshall Long.

Mr. Herman was the former Planning Commissioner for District III, having been appointed January 5, 2016. He meets the qualifications and has expressed interest in continuing to serve on the Mariposa County Planning Commission.

This action is based on the recommendation of District III Supervisor Long.

This position has been advertised according to the Maddy Act.

Terms of regular members shall coincide with the term of the supervisor of the district which the member represents at the time of appointment. Reelection of the supervisors of that district shall not constitute reappointment of the Planning Commission member.

### **BACKGROUND AND HISTORY OF BOARD ACTIONS:**

Mr. Herman's term as District III Planning Commissioner expires January 7th, 2019. Mr. Herman will continue to serve on the Planning Commission pending an appointment, per Mariposa County Code, Title 2, Section 2.52.030.

### **ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:**

Not re-appointing a Planning Commissioner could result in a lack of quorum for the Commission, as well as no representation for District III.

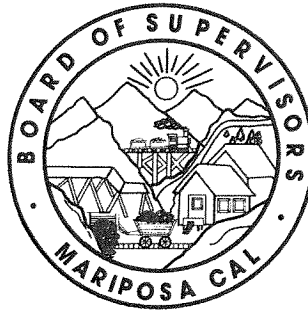


