WHEREAS, in order to provide emergency medical care for the inhabitants of the County of Mariposa, and pursuant to the joint powers provision of the Government Code (Section 6500 through 6514), and

WHEREAS, the County of Mariposa, pursuant to Health and Safety Code Sections 1443 and 1445 desires to provide health services and transportation to and from the hospital for the indigent residents of the County of Mariposa.

THEREFORE, BE IT RESOLVED, that the Joint Powers agreement between the County of Mariposa and the John C. Fremont Hospital in which the County agrees to grant to the Hospital the sum of \$8,500.00 to be used for the purpose of purchasing a new emergency van-type vehicle for the benefit of the residents of the County of Mariposa is hereby approved and the Chairman of this Board is authorized to execute same.

This agreement is made and entered into this 23rd day of January, 1973 between the County of Mariposa, hereinafter called "County", and the John C. Fremont Hospital, hereinafter called "Hospital"; each of which is a political subdivision of the State of California, is made in view of the following:

WHEREAS, pursuant to the joint powers provision of the California Government Code (Sections 6500 through 6514), the parties have entered into this agreement; and,

WHEREAS, the parties hereto have the power in common to provide emergency medical care for the inhabitants of the County of Mariposa and,

WHEREAS, the County does not maintain a County Hospital; and,

WHEREAS, the hospital is in need of and desires to purchase a new emergency van-type ambulance; and,

WHEREAS, the County, pursuant to Health and Safety Code Sections 1443 and 1445 desires to provide health services and transportation to and from the hospital for the indigent residents of the County of Mariposa.

THEREFORE, IT IS MUTUALLY AGREED between the parties hereto as follows:

I.

The County agrees to grant to the Hospital the sum of \$8,500.00 to be used for the purpose of purchasing a new emergency van-type vehicle for the benefit of the residents of the County of Mariposa.

In consideration therefor, the hospital agrees to acquire, maintain, insure, and staff the ambulance for a period of five years, and to provide transportation to and from the hospital for all indigents of the County without any cost to the County for said services for a period of five years.

III

In the event that the ambulance so purchased should be destroyed, whether by fire, or misfortune, this contract shall terminate.

IN WITNESS WHEREOF, the parties hereto pursuant to resolutions of their respective governing boards have caused this joint powers agreement to be executed this 23 day of January, 1973.
