

AGREEMENT NO. EEA 02-214

GRANT NO. EA 06-2-0059

MODIFICATION NO. 8

REGISTRATION NO. 72006663

This modification to agreement No. EEA 02-214 under the Emergency Employment Act of 1971, hereinafter "the agreement", is entered into this 5th day of February, 1973 by and between the State of California, Department of Human Resources Development, hereinafter "Program Agent", and Mariposa County, Hereinafter "Subagent".

WHEREAS, Program Agent and Subagent entered into the agreement on September 28, 1971, and

WHEREAS, Program Agent and Subagent now desire to modify the agreement,

NOW, THEREFORE, IT IS AGREED THAT:

1. The termination date of the agreement shall be extended from February 15, 1973 to June 30, 1973 unless sooner terminated pursuant to direction by the Department of Labor.
2. The total amount of this contract shall not exceed \$ 103,415 which is an increase in the maximum obligation of the Program Agent from \$42,953 to \$103,415. This increase is subject to the appropriation and availability of Federal funds and the State shall incur no liability under this amendment unless such funds are appropriated and available for the performance hereunder. The subagent will be notified in writing as funds for performance are available and allocated to this contract as amended. Such notice shall identify the specific amounts available for expenditure by cost category consistent with the attached Budget Estimate.

3. Expenditures by Subagent shall be in accordance with the attached Budget Estimate. Revision No. 8 (MA6-50) shall supersede Budget Estimate Revision No. 7. The contractor shall not be paid in excess of actual costs incurred, which in no event shall exceed the total dollar amount of the contract.

4. The amount Program Agent shall pay Subagent shall be geographically allocated and expended as set forth in the attached geographical Allocation of Fund.

5. Except as hereby modified, all terms and conditions of the agreement shall remain unchanged.
