

1 BOARD OF SUPERVISORS - COUNTY OF MARIPOSA

4 WHEREAS, the passing of Clair T. Wolfson, our dear
5 friend and beloved citizen of Mariposa County for many years,
6 has affected the people of Mariposa County, more than words can
7 express, and left the memory of his wisdom and kindness, his
8 whole-hearted earnestness and sincerity, his devotion to Mariposa
9 County more fresh with us on account of his sudden call; and

10 WHEREAS, Clair T. Wolfson, during his lifetime established
11 a home in Mariposa County in 1933 and in 1941 started his own
12 cattle ranching operation, which he operated until his untimely
13 death. He was a director of the Mariposa County Fair, member of
14 the Mariposa Range Improvement Association, member of the Soil
15 Conservation District of Mariposa and the Agricultural Stabiliz-
16 ation Committee. He served as a member of the Merced College
17 Advisory Committee for the formation of the school's department
18 of agriculture and was an active member of the Farm Bureau and
19 the IOOF Lodge; and

20 WHEREAS, because of his character and leadership, he was
21 held in deep regard by all members of the Board of Supervisors of
22 Mariposa County, the County Officials of Mariposa County and the
23 citizens of Mariposa County who knew him so well; and

24 WHEREAS, our duty toward our departed friend and our
25 sincere sympathy toward his bereaved family require that we be
26 mindful of him;

27 NOW, THEREFORE, BE IT RESOLVED that in the passing of
28 Clair T. Wolfson each citizen of Mariposa County has lost a real

1 friend; that we express to his family our sincere expression of
2 deepest regret and most heartfelt sympathy, and that we express
3 the hope and belief that the family's sadness and sorrow will be
4 softened by the memories of his fine and generous qualities.

5 BE IT FURTHER RESOLVED that a copy of this resolution
6 be spread upon the minutes of this Board and a copy thereof be
7 sent to the family of Clair T. Wolfesen.




