11 Minor Arterials (Blue)

- 12 1. All of State Highway 140 from Mariposa County
13 Line to Yosemite National Park Boundary
- 14 2. All of FAP 341, All of FAP 20, and all of FAP 78
15 within Mariposa County and Yosemite National Park.

16 Connector (Yellow)

- 17 1. All of State Highway 49, FAS 554 and FAS 963 within
18 Mariposa County.
- 19 2. All of Highway 132 lying within Mariposa County.
- 20 3. All of FAS 964 between State Highway 140 and State
21 Highway 49.
