

1 BOARD OF SUPERVISORS - COUNTY OF MARIPOSA

2 RESOLUTION NO. 73-111

3 WHEREAS, on August 7, 1973, Mariposa County passed Resolution
4 No. 73-87 claiming Mariposa County's interim apportionment for
5 Fiscal Year 1973-74 under California's Secondary Act of 1951, as
6 amended, and Public Law 93-61.

7 WHEREAS, on October 26, 1973, the State Highway Engineer
8 forwarded official notice of amounts due Mariposa County under
9 the Federal Aid Highway Act. (Fiscal Year 1973-74), in accordance
10 with provisions of Section 2208 and 2210.5 of Streets and Highways
11 Code, as follows:

12 Federal-Aid Secondary Funds \$79,011

13 State Highway Fund Money for Matching \$39,506

14 WHEREAS, Section 2211 of the Streets and Highways Code re-
15 quires the County within 60 days of receiving such notice to
16 notify the State Highway Engineer as to what amount of the
17 apportionment the County wishes to claim and to agree to provide
18 any county matching funds as may be necessary after first con-
19 sidering the sum made available under Streets and Highway Code
20 Section 2210.5.

21 WHEREAS, Section 2208 of Streets and Highway Code, as amended
22 by Chapter 1505 of the Statutes of 1970 provides that a County
23 whose FAS apportionment is less than \$100,000 may exchange such
24 FAS funds for an equal amount of Non-Federal money from the State
25 Highway Fund if it uses all of the money apportioned or exchanged
26 to construct highways to standards of the Federal Aid Secondary
27 System.

28 NOW, THEREFORE, BE IT RESOLVED AND ORDERED that the County

1 of Mariposa does hereby rescind Resolution No. 73-87 dated
2 August 7, 1973, claiming Mariposa County's said interim appor-
3 tionment for fiscal year 1973-74; and

4 BE IT FURTHER RESOLVED that the County of Mariposa does
5 hereby notify the State Highway Engineer that the County of
6 Mariposa claims the said apportionment and the whole thereof,
7 and the County of Mariposa does hereby agree to provide any
8 County matching funds required as may be necessary after first
9 considering the sum made available under Streets and Highways
10 Code Section 2210.5; and

11 BE IT FURTHER RESOLVED that the County of Mariposa desires
12 to exchange its entire apportionment of Federal Aid Secondary
13 money for an equal amount of Non-Federal money from the State
14 Highway Fund, with the proviso, that said Non-Federal "exchange
15 money" and the above apportionment of State Highway Fund money
16 for matching, will be used to construct highways to the standards
17 of the Federal Aid Secondary System.
