State Center Credit Union has received your request to join the credit union and the board has met and voted to begin the process of formal application.

There are several requirements for your governmental subdivision to meet before your application may be reviewed and accepted by our Board of Directors, after which the application must be sent to the California Division of Corporations for approval, as follows:

1. Proof that your agency is a governmental subdivision (letter stating your function and source of employment will suffice.)
2. Proof or confirmation that you are a Civil Service Agency (advise number of employee potential)
3. Proof or confirmation that your governmental organization exists within our assigned geographical area (Fresno, Madera, Mariposa, Merced, Kings, and Tulare Counties)
4. Substantiation that you belong to the Public Employees Retirement System of California, written copy from the clerk or treasurer.
5. Resolution from employing agency (Board of Supervisors) that they agree to ^{allow} payroll deductions from the employee's paycheck and forward an employee list with the amount deducted each month (before the 15th) to State Center Credit Union.

When you have prepared a letter confirming the above along with a certified copy of the resolution from the employing agency agreeing to payroll deduction, your application will be reviewed at the next regular board meeting, normally the second Tuesday of each month.
