RESOLUTION NO. 70-4

RESOLUTION ESTABLISHING COULTERVILLE COUNTY SERVICE AREA NO. 1 AND  
FIXING THE BOUNDARIES THEREOF

WHEREAS, there was filed on November 12, 1969, with the Clerk of the Board of Supervisors, County of Mariposa, State of California, a written petition for the establishment of a County Service Area; and

WHEREAS, on December 16, 1969, this Board ordered a hearing to be held on said petition, fixed January 20, 1970 at 2:00 o'clock p.m. at the Courthouse as the time and place for said hearing, and directed the Clerk to publish notice in accordance with Section 25210.16 of the Government Code; and

WHEREAS, said notice was duly published in accordance with said order; and

WHEREAS, said hearing was held on January 20, 1970, at which time no public opposition to the formation of the Service Area as petitioned was presented; and

WHEREAS, the Board, after discussion on the merits of formation of the said Service Area by the Board, the hearing was closed;

NOW, THEREFORE, the Board of Supervisors of the County of Mariposa, State of California, does hereby resolve, determine and order that:

1. The foregoing recitals, and each of them, are true and correct and the Board of Supervisors hereby so finds and determines.

2. This Board of Supervisors has reviewed all proceedings heretofore taken and has found as a result of such review and does hereby determine that all acts, conditions and things required by law to be performed prior to the establishment of a County Service Area have been performed in the time, form and manner as required by law.

1 to be duly organized pursuant to the County Service Area Law, Title  
2 3, Division 2, Part 2, Chapter 2.2, of the Government Code.

3 4. The purpose for which said COULTERVILLE COUNTY SERVICE AREA  
4 NO. 1 is formed is to provide the following services:

5 (a) Water and Sewer System.

6 5. Except where funds are otherwise available from service  
7 charges collected pursuant to Section 25210.77a of the Government  
8 Code Tax sufficient to pay for all such services which are fur-  
9 nished on an extended basis will be annually levied upon taxable  
10 property within such area.

11 6. The boundaries of COULTERVILLE COUNTY SERVICE AREA No. 1  
12 shall be that area in the townsite of Coulterville, County of  
13 Mariposa, State of California, more particularly described in  
14 Exhibit A, attached hereto and made a part hereof.

15 7. The Clerk of the Board shall cause a copy of the map and  
16 a description of the boundaries of said COULTERVILLE COUNTY SERVICE  
17 AREA NO. 1 to be promptly filed with the State Board of Equaliza-  
18 tion and the Assessor of the County of Mariposa, in compliance with  
19 Section 54900, et seq., of the Government Code.
