9 ification plan, with each employee entering employment at the
10 first step of the salary range classification provided for his or
11 her employment, or such step thereof as the Board of Supervisors
12 shall by minute order designate at or after the time of hiring, to

24 five steps of the range classification. New employees may be re-
25 cruited at a lower salary range and job classification than those
26 set forth in this Resolution.


