**FIRST AMENDMENT TO AGREEMENT TO PROVIDE TRANSIT SERVICES**

**THIS FIRST AMENDMENT TO AGREEMENT TO PROVIDE TRANSIT SERVICES** is made and entered into this 11<sup>th</sup> day of June, 2019, by and between the County of Mariposa, a political subdivision of the State of California, hereinafter referred to as “**County**”, and Yosemite Area Regional Transportation System, hereinafter referred to as “**Contractor**”.

**WHEREAS**, the **County** and **Contractor** have heretofore entered into an Agreement dated April 2, 2019 and effective on July 1, 2019, wherein **Contractor** agreed to provide public transit services to and from Mariposa County; and

**WHEREAS**, **County** and **Contractor** desire to amend said Agreement to change the compensation terms;


**NOW, THEREFORE**, the parties hereto in consideration of the mutual covenants herein recited, hereby agree as follows:


1. Paragraph 3. “COMPENSATION”, is hereby amended to delete the sentence “The County shall pay Contractor within thirty (30) days of receipt of an approved invoice.”
2. Except as herein amended, the Agreement dated April 2, 2019 and effective on July 1, 2019, shall remain in full force and effect.
