A resolution recommending that the Board of Supervisors accept the 2019 General Plan Annual Report and approve the 2019 Schedule of General Plan Amendments, County Project No. 2019-025

WHEREAS, the laws of the State of California require Mariposa County to adopt and maintain a General Plan to guide the long-term development of the County, pursuant to Government Code Section 65300 et seq.; and

WHEREAS, State Government Code Section 65400(a)(2) requires that an annual report be prepared on the progress in the implementation of the General Plan, and the progress the County is making with regard to meeting its share of regional housing needs; and

WHEREAS, a draft 2019 General Plan Annual Report was prepared in accordance with the requirements of the State law, and was made available for public review; and

WHEREAS, a duly noticed Planning Commission public hearing and workshop on the 2019 General Plan Annual Report was scheduled for the 8th day of March, 2019; and

WHEREAS, the Planning Commission did hold a public hearing on March, 2019 and considered the information provided by County Departments and in the public record, including the 2019 General Plan Annual Report.

NOW THEREFORE, BE IT RESOLVED THAT, the Planning Commission of the County of Mariposa does hereby recommend that the Board of Supervisors accept the 2019 General Plan Annual Report, and approve the 2019 Schedule of General Plan Amendments as shown in Exhibit A; and forward it to the State Department of Housing and Community Development and the State Office of Planning and Research. The Planning Commission recommends the Board find these actions are categorically exempt from environmental review pursuant to the California Environmental Quality Act (CEQA) Guidelines, Section 15306.


