RE: Approve CDPH Grant Agreement for CalFresh Healthy Living Nutrition Education

RECOMMENDATION AND JUSTIFICATION:

Approve Grant Agreement 19-10374 with the California Department of Public Health (CDPH), Nutrition Education and Obesity Prevention Branch (NEOPB) for the CalFresh Healthy Living (formerly SNAP-Ed) nutrition education program in the Amount of \$450,000 for Federal Fiscal Years 2020-2022; and Authorize the Health and Human Services Agency Director to Sign the Grant Agreement, Exhibit F, and the Contractor Certification CCC-307. This NEOPB CalFresh Healthy Living Grant Project begins October 1, 2019 and terminates September 30, 2022.

The program will provide nutrition education and obesity prevention activities and interventions for low-income residents of Mariposa County. The focus of CalFresh Healthy Living is health promotion to help the eligible target audience establish healthy eating habits and a physically active lifestyle, reduce food insecurity, and for primary prevention of nutrition-related chronic diseases.

The NEOPB Mariposa 2018 County Profile data indicates that 64.0% of adults are overweight or obese, and 37.0% of youth ages 12-17 are overweight. In Mariposa County, 16% of people face food insecurity, including 22% of youth under 18 years of age. Primary objectives for CalFresh Healthy Living Education in Mariposa County are to deliver school wide interventions to promote healthy choices and physical activity in four (4) Mariposa County Unified School District elementary (K-8) schools, and to encourage increased fruit and vegetable consumption and a physically active lifestyle for residents of all ages.

BACKGROUND AND HISTORY OF BOARD ACTIONS:

The Board of Supervisors approved the existing agreement on June 21, 2016 by Resolution No. 2016-310.

ALTERNATIVES AND CONSEQUENCES OF NEGATIVE ACTION:

Without this Agreement in place, the Public Health Branch will be unable to receive CDPH NEOPB funding to improve access to and choices for affordable healthy food and physical activity for low-income children and adults in Mariposa County.

FINANCIAL IMPACT:

There is no impact to the County General Fund. This project is 100% grant funded. Grant amount shall not exceed \$450,000 for a term beginning October 1, 2019 and terminating on September 30, 2022. The appropriate grant revenue and appropriations have been included in the Requested Budget for Fiscal Year 2019-20 in the Health 001-0401 operating budget.
