RECOMMENDATION AND JUSTIFICATION:

Authorize the Board of Supervisors Chair to Sign a "Letter of Public Convenience and Necessity" to the Department of Alcohol Beverage Control to Issue a Type 20 Off-Sale Beer and Wine Licenses that would otherwise be subject to the State Moratorium, Census Block 06-043-010-001, for the Building Located at 2675 Highway 140, Suite A, Catheys Valley.

Staff supports the request, recognizing that many of the county's commercial establishments serve the tourists who visit Mariposa County and Yosemite National Park.

This commercial space is known as the Oasis.

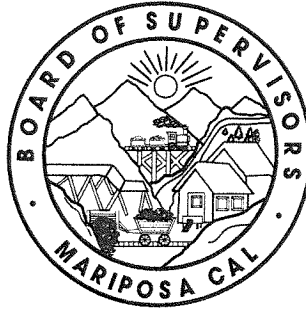
